The first was when I received a random message from Tim Tayshun - who claimed he heard I was trying to speak to him - which was a complete lie.

We were not FB friends so I was confused as to how he could have known about me and connected by FB messenger unless he had been told to by someone who knew I was in onelife and was trying to cause trouble.

At that point in time - I know that Jen McAdam had told diamond leaders in our business that she was 100% in onelife and had been added back to all the team whatsapp groups which is why I say to Tim in these messages that I heard she was 100% promoting onelife. And he says the opposite.

I will send you all the screenshots. He was coming across as pretty psychotic and so I blocked him on FB after the last messages here...

I had heard she had a group running and am very concerned that I see one of my team members Linsey [REDACTED] is in the group which I understand is spreading lies about onecoin and saying it is a scam...

[color=]A short while later I received a phone call from an unknown number who said he was Bjorn and started asking me what my involvement with onecoin was - he asked me my rank and how much money I was earning and so I asked him what his full name was and why was he phoning me?

[color=]He said he was Nordic and his name was Bjorn Bjerke and so I asked in what capacity he was calling me - he said he knows everything about me - he knows I am using an iPhone right now, he knows every text, message and phonecall I make and every picture I take and send and he knows I am actively involved in a global criminal operation and that I need to stop immediately - said that I would end up with a prison sentence no matter what bit that I will be arrested and locked up for longer if I don't make a phonecall to the police within 24 hours.

The man who called me definitely said he was Bjorn Bjerke and he sounded like this man in the video but was very angry towards me.

I am now scared into helping my team recruit people and worried to bring anyone into my network in case they are also contacted by this man or have to deal with anything from Jennifer McAdam.

I also randomly had messages from Tim Tayshun a few weeks ago via FB messenger which were equally scary.

I should like your advice on if I should phone the police about this also please.

A statement or press release or company video or anything from the legal department or from Dr Ruja would definitely go a long way to stop the fear from affecting my business and the businesses of my team members who joined to help others benefit from the onelife opportunity. We are all frightened right now and don't really know how to move forward.

I was going to go to the Macau global event but I actually no longer think I can afford to - this has had a really big impact on my earnings. I joined the business to help others and earn money and I am in a panic now.

I am a single mum of 5 and you can imagine what a terrible situation this puts me in.
