Review of Political Activities

Overview

The Covid 19 Pandemic continued to impact campaigning in 2021, but despite this we ran a very successful election campaign for the Suffolk County Council and Ipswich Borough elections, as well as the East Suffolk Council Framlingham ward by-election.

Membership

Unfortunately, membership has continued with the downward trend from 2020.

The Covid 19 Pandemic continued to impact Branch fundraising events in 2021, but the Mendlesham Branch were able to resume holding their annual Big Blue Bash in the Summer, and North Ipswich Branch were able to host a Dinner with a Guest Speaker, both raising some vital funds for the Association.

Committees

The Executive Council is responsible for the overall direction and control of the activities of the Association. The Executive Council met four times during the year, one of the meetings being the Annual General Meeting.

The day-to-day business of the Association is administered by the Management Committee. The Management Committee met four times during the year, one of those again being the Annual General Meeting.

Campaigning

Whilst campaigning continued to be hampered by the Covid 19 Pandemic, many of our Candidates were able to canvass in their communities shortly before the local elections in May 2021. A total of 14 candidates (5 of which were cross constituency) were fielded in the Suffolk County Council elections, with all 11 previously held seats being retained, plus gains in the Gipping Valley division and for the second seat in the Whitehouse and Whitton division. In the Ipswich Borough Council elections, both seats were retained in the Castle Hill Ward, along with a gain in the Whitton Ward from Labour. The Framlingham by-election in East Suffolk Council was also won by our candidate.

Review of financial Activities for 2021

Overview

Sadly, the Covid 19 Pandemic continued to hamper the Association and Branches fundraising efforts during 2021. The Association did not host any fundraising events in 2021, however, we once again had a good response to the National Conservative Christmas Draw, in comparison to years previous, raising a total of £708 for the Association.

Overall, there was a deficit of £4,582 as evidenced by the Income and Expenditure Account in the Consolidated Accounts.

Income & Expenditure

Income

Our income from subscriptions for 2021 was £11,843, which was down by £2,626 from 2020. Fund raising was up from £1,193 in 2020 to £4,519 in 2021, in light of two of the Association's branches being able to host fundraising events.

Expenditure

Expenditure was up in 2021 totalling £26,961, compared to £15,512 in 2020. The increase in expenditure was primarily as a result of the local elections costs. The Association's general running costs remained comparable to 2020, with the exception of rent and office overheads, which saw a decrease due to the fact that the Association now has a virtual tenancy agreement.

Balance Sheet

We ended 2021 with a deficit of £4,582 for the year. Net assets at the end of the year are £27,917 compared to £32,499 in 2020.
