# Financial Statements for the year ending 31 December 2021

#### Introduction

This statement reports on the political and financial activities of the Arfon constituency of Plaid Cymru — The Party of Wales.

The Party's registered address in the constituency is 8 Stryd y Castell, Caernarfon, Gwynedd, LL55 1 SE.

The registered Treasurer for the purposes of the Political Parties, Elections and Referendums Act 2000 is Gareth Wyn Roberts.

#### Review of political activities

#### 1. Overview

The Party's main political activities in the constituency were as follows:

- Supporting the work of Hywel Williams, the Member of Parliament for Arfon, and Siân Gwenllian, Member of the Senedd for Arfon and the Plaid Cymru Councillors for Gwynedd Council.
- Senedd Election May 2021 re-electing Siân Gwenllian.

#### 2. Membership

At the end of 2021 there were 1,031 members in the Arfon constituency.

#### 3. Branches

There are 9 branches in the Arfon constituency.

#### 4. Committees

The Membership Committee is formed by representatives from each branch, a Member of Parliament, a Member of the Senedd and County Councillors. The committee meets every month during the year, with the exception of August and December, to co-ordinate the Party's activities across the constituency.

#### **Income and Expenditure**

Like last year, membership subscriptions, gifts, regular rent receipts and fundraising activities were the main sources of income.
