Political activities

Overview of political activities

A personally addressed survey was delivered to electors in target wards of the City. This was followed up by a newsletter issued by our Conservative councillors. A number of single issue flyers were delivered throughout the City. Nottingham Conservative activists were also out most weekends ward helping neighbouring Gedling MP Tom Randall deliver his newsletters.

Nottingham Conservative officers and councillors maintained contact with television, radio and social media, keeping attention on the Labour led City Council's financial incompetence and lack of transparency.

Financial activities

Income overview

Nottingham Conservatives held two very successful fund raising dinners and they received a generous legacy from a former trustee and branch President. Rental income fell due to the end of a lease to the Crown Prosecution Service and income from ad hoc office services fell as neighbouring associations ceased using our services for postage etc.

Expenditure overview

Continuing expenditure

There was a decrease in office costs due to the reduced provision of services to neighbouring associations, but this was offset by costs of cancelling minority shares and ending the Crown Prosecution lease.

Additional investment

No additional investments were made during the year.

Balance Sheet overview

Nottingham and County Constitutional Club Company Limited has been fully consolidated into this statement, but the cancellation of minority shares meant that the £64,573 of reserves previously due to minority shareholders could be credited to Nottingham Conservatives.

Accounting notes

Accruals or cash accounting - Changed?

These accounts have been prepared using the accruals accounting method, the same as previous years. Property held in trust has been fully consolidated. Memberships subscriptions are now shown net of the element due to CCHQ.
