### The Pendle Conservative Association Introduction and review of political activities Year ended 31st December 2022

#### Introduction

This Statement of Accounts provides a report on the political and financial activities of the Pendle Conservative Association. The Association's registered address is:



For the purposes of the Political Parties Elections Referendums Act 2000, David Brown (the Association Treasurer), is the Registered Treasurer.

#### Review of political activities

In 2022, there were Pendle Council Elections in May and a by-election in the Barrowford and Pendleside Ward on 15th December.

After gaining control of Pendle Council in the all-out elections of May 2021 (Con 18, Lab 10, Lib Dem 5), the death of longstanding Councillor Linda Crossley (Barrowford and Pendleside) in February and the defection of Cllr Mohammed Adnan (Marsden and Southfield) to Labour in March, provided a difficult backdrop to the May elections. This was further complicated by the decision of Cllr Darren Harrison (Waterside and Horsfield) and Cllr Donna Lockwood (Vivary Bridge), both elected in May 2021, not to seek re-election. We also lost our Agent, who left to take on a regional role with the Conservative Party, meaning our Association Chairman Adrian Mitchell MBE had to step in as election agent. The Lib Dems and Labour Party also clearly co-ordinated their nominations to cause us maximum difficulties, with for example no Labour candidate in Earby and Coates and no Lib Dem in Barrowford and Pendleside. Despite all these challenges in the May elections, we retained our seats in Barrowford and Pendleside (x2), Boulsworth and Foulridge, Vivary Bridge (x2) and Waterside and Horsfield. Mohammad Kaleem gained a seat in the Bradley ward (from Labour) and our only loss was in Marsden and Southfield where Karen Howarth lost to Labour. Our candidate Mohammed Arshad also fell just 109 votes short of gaining the Brierfield East and Clover Hill ward from Labour. The new political balance of Pendle Council being (Con 17, Lab 11, Lib Dem 5). The Association would like to thank all the candidates who stood and our volunteers who made this result possible.

On 1st October Cllr Carlo Lionti (Barrowford and Pendleside) sadly died triggering a by-election which was held on 15th December. Assisted by our new Campaign Manager, Adam Brierley, our candidate David Gallear held the seat. The shares of the vote were, Conservative 57.3% (-1.4), Labour 35.8% (-5.5) and Lib Dem 6.9% (+6.9%) which represented a small swing towards us, which was very encouraging for a by-election.

In November, revised proposals from the Boundary Commission for England recommended the creation of a new Pendle and Clitheroe seat, which would be composed of 55,330 electors from the current Pendle constituency and 21,611 electors from the current Ribble Valley constituency. The final recommendations will be published in 2023, however these new boundaries will significantly change the nature of our political activities as the proposed new constituency would be composed of ten Pendle Council wards and 10 Ribble Valley Council wards.

Finally, throughout 2022 Pendle Conservative Association continued to support the incumbency campaigns of our Member of Parliament, the Rt Hon Andrew Stephenson CBE MP.
