Introduction

This statement of accounts provides a report on the political and financial activities of the Plaid Cymru - the Party of Wales, Ynys Môn constituency. The constituency party's registered address is

For the purposes of the Political Parties Elections Referendums Act 2000, David James is the registered Treasurer.

Review of political activities

1. Overview

The main political activity in the constituency was campaigning in a by-election for a seat in the Ynys Môn County Council.

2. Membership

At the end of 2023 the Ynys Môn constituency had 419 members.

3. Branches

There are 5 branches in the constituency.

4. Committees

The Constituency Committee has been formed in accordance with Plaid Cymru's national standing orders. It held monthly meetings throughout the year to co-ordinate party activities across the constituency and to support the Senedd Member. Some of the meetings were held face to face and others on line.

Sub-committee meetings took place in addition during the year.

5. Campaigning

Following the death of a councillor a highly successful period of campaigning took place during the spring which resulted in Plaid Cymru retaining a seat in the Aethwy Ward of the County Council. The enthusiastic and energised nature of the campaign continued following Rhun ap Iorwerth's installation as prospective parliamentary candidate for the forthcoming Westminster general election. This campaign was paused following Rhun's election as Leader of Plaid Cymru, thus making him ineligible for the Westminster role. Campaigning was subsequently restarted with Councillor Llinos Medi being installed as prospective parliamentary candidate in Rhun's place.

Review of financial activities

Overview

The main financial items during the year, in respect of income, were: donations of $\pounds 11676$, rental receipts of $\pounds 11436$, and $\pounds 12787$ headquarters' contributions. In relation to expenditure, the main items were $\pounds 17227$ on employing the Organiser and $\pounds 15104$ in campaigning costs.

The accounts reflect income from various sources under sub-headings such as donations and, membership subscriptions to provide a clear picture of the party's sources of funding in the constituency.

Income and expenditure

Donations from individuals and rent received were the principal sources of income. Employing an Organiser and campaigning costs were the main items of expenditure.

Balance sheet

Funds in reserve were slightly higher than the preceding year because income was greater than expenditure received for the year.

1. Accounting polices

The financial statements have been prepared in accordance with applicable accounting standards and guidance issued by the Electoral Commission. Fixed assets have been capitalised on the basis of their historical cost.

2. Accounting convention

The statements are prepared on an historical cost basis.
