Expenditure overview

Office and staff cost increases were significant, and steps have been taken to reduce both.

One unsuccessful bye-election was fought following the sad passing of one of our members and sitting North Yorkshire Councillors, Margaret Atkinson which incurred costs, but overall campaigning costs were much lower this year as might be expected.

Unfortunately, it was not financially possible to repay the whole of the loan repayment that was due in the year, or the Corporation Tax that was payable, so additional interest costs have been incurred.
