### **REVIEW OF POLITICAL ACTIVITIES**

In April we selected Michelle Scrogham as the Prospective Parliamentary Candidate for Barrow And Furness and we are now actively campaigning for her election.

The Barrow Borough Council, South Lakes District Council and Cumbria County Council were abolished and replaced with the Westmorland And Furness Unitary Authority (WAF) in May 2023.

There was a by-election for this authority following the sad death of one of the councillors - which we won.

A new Barrow Town Council was also formed in May of 2023 and the CLP put up 21 candidates of which 19 were elected.

### **REVIEW OF FINANCIAL ACTIVITIES**

Four activities dominated the finances for 2023.

### The selection and promotion of a Prospective Parliamentary Candidate.

Michelle Scrogham was selected in April of 2023,

We organised and paid for the selection process and the hustings – under the supervision of Regional.

The PPC decided to open her own campaign account – that is not reported on here – and following selection our main financial interaction with this campaign has been the transfer of funds to that account.

### The Election for Barrow Town Council and by-election for Westmorland And Furness Council

In April and May of 2023 we organised the election of 19 councillors to the Barrow Town Council and one councillor to the Westmorland And Furness Unitary Authority,

This election was mainly funded by a donation from a fund set up for the re-election of Barrow Borough Councillors.

#### 3. Conference

We sent three delegates to conference – this being funded by a generous donation by a party member and by two of the candidates funding their own accommodation.

### 4. The Refurbishment of Broadcasting House

Last – but far from least – was the refurbishment of Broadcasting House. We took out a loan from the Central Labour Party of £30,000 which was used to refurbish the building and pay off various fees associated with the move from

Please note that because the loan is from the National Labour Party the loan and repayment are shown as Transfers.

Work included the addition of Double Glazing, the replacement of the Gas Central Heating system with a modern eco-friendly Far Infrared Heating system and the separation of the studio and community hall. There was a fundraising request to complete the work – which inflated funds at the end of the year.

The work was completed in January 2024.

This work dominates the finances of 2023.
