REVIEW OF POLITICAL ACTIVITIES

This year has been a challenge, both organisationally and electorally, but there are many reasons to also be positive as we head into what is likely to be a General Election year in 2024.

Electorally, we have had a challenging year. This was mainly due to the difficulties surrounding the proposed Sustainable Travel Zone (STZ) for Cambridge. In May, although of re-standing Labour candidates won re-election and Labour won 10 of the 16 seats being contested, we lost Newnham Ward to the Greens and Market to the Liberal Democrats. Following the resignation of a Labour councillor for Kings Hedges immediately after the local elections, we then lost that ward's by-election to the Conservatives by just 24 votes. This was the first time the Conservatives have won any ward in Cambridge for over a decade. In November, we came close to winning the Queen Edith's by-election, being just 64 votes behind the Liberal Democrats.

MEMBERSHIP

Full membership at 31 December 2023 was 1655 excluding Cherry Hinton and Queen Edith's wards (2034 in 2022).

REVIEW OF FINANCIAL ACTIVITIES

- 1. Total income in 2023 was £88,346.96 (£83,734.73 in 22) and total expenditure £73,520.84 (£77,751.01 in 22)
- 2. Excluding money held in separate branch bank accounts, the CLP made a surplus this year of £14,826.12. In 2022 the CLP's surplus was £5983.72.
- 3. Without a rates rebate of £7825.65 net and an NEC grant of £12,249.96, which met almost half of our staff costs, we would have been £5249.49 in deficit.
- 4. Financial prospects for 2024 are uncertain.
- Accumulated current reserves, excluding funds held in separate branch accounts, total £43,618,97.
 Branch accounts contained at least £5353.99 in 22 but some ward treasurers have not sent 2023 information to the CLP treasurer.
- 7. The CLP relies heavily on its Guaranteed Income Scheme which raised £15,328.50 in 2023 (£14,030.50 received in 22).
- 8. Some members seem reluctant to donate on a regular basis— one factor is that they consider that more of their membership fees should be returned to their local CLP.
- 9. Other sources of funds continue to include part of the 5% allocated by City and County Labour Groups 'for the purposes of effective and vibrant electoral organisation' as required by LP rules. It is difficult to predict how much will be received from the Cambs County Council Labour group, all of whose members represent Cambridge wards and are supported electorally by the Cambridge CLP.
- 10. The CLP is grateful to the city ward branches which contribute up to £2 per member per year to support its campaigning activities.
- 11. Fundraising is not substantial. Thanks are due to Stephanie Shaw who ably runs our 100 Club, to Virginia Yates who set up another successful auction of promises and to who organised a film show. Much appreciated; more needed.- good for morale and good for our funds...
