Chairman's Report

2023 unusually was an election-free year here in Scotland, but preparations got underway for the General Election to be held in 2024.

This started with the re-adoption of Andrew Bowie MP in March followed by David Duguid MP in June which allowed the selection to take place for the Gordon & Buchan constituency where Harriet Cross was the successful candidate.

Work during the year included leafleting and the collection of Voter Intentions together with fundraising activities to build up funds for the General Election.

The year started with the West Aberdeenshire & Kincardine branch hosting a major fundraising dinner in February with Rt Hon Theresa May MP as the special guest. Several other fundraising events followed throughout Aberdeenshire, culminating with each of the 3 branches holding Christmas Lunches – all of which were extremely successful.

During the year the Association reformed the Gordon Branch to support the selected candidate. The branch held a number of successful fundraising events.

During 2023 the three branches participated in the usual round of markets, fairs and summer shows in order to fly the flag and to raise much needed funds for the campaign ahead.

Membership has held steady during 2023 despite the ups and downs of the Party nationally. Additional income is derived from rental income, together with contributions from elected representatives for office support and regular newsletter updates.

Expenditure

Expenditure is based on running branch offices and employment of staff. The costs included producing and distributing promotional materials for selected Candidates and Elected Representatives. There are no extraordinary items of expenditure to report.
