Introduction

This Statement of Accounts provides a report on the political and financial activities of the Basildon and Thurrock Conservative Federation, whose registered address is:

For the purposes of the Political Parties Elections Referendums Act 2000, Mr Shane Hebb is the Registered Treasurer.

Basildon & Thurrock Conservative Federation has two elected Members of Parliament, Jackie Doyle Price MP representing Thurrock and Stephen Metcalfe MP representing South Basildon & East Thurrock.

These accounts were prepared by Ian Foster (Treasuer) for 2023. They have been reviewed by They present a consolidated view of Federation accounts including the branches which includes fighting funds for our MPs and CWO funds.

Political Activities

Overview

The activities this year have included campaigning for the local elections with both Basildon and Thurrock councils under Conservative control, in addition campaign activities have been undertaken to raise the overall profile of The Conservative Party throughout South Basildon and Thurrock.

Branches

Following a restructure of the branches during 2023 the Basildon and Thurrock Conservative Federation now has 7 branches, in addition to the Federation account, 3 of the branches have a bank account.

Review of financial activities

Overview

Income Overview

Income for the federation is primarily driven by membership, fundraising and elected members monthly precept contributions. This is supplemented by both ad hoc and regular donations.

Expenditure Overview

There are two main drivers for expenditure within the Federation, firstly campaign and promoting costs, secondly, general running costs for the office of the federation.



Our results show a loss from expenditure over income of £6,722.46 in large part due to the costs associated with our the 2023 local election campaign.

Balance sheet

Our balance sheet is positive with net assets of £9,343.83

Accounting convention

The statements are prepared on a cash accounting basis for the period under review and are fully reconciled to bank statements of the Federation and all branches.

Treatment of Assets

A full reconciliation of assets has been performed, since 2018, when fixed assets were stated as £2,500.00, we have invested a further £4,098.47 in new fixed assets which between the end of 2018 and the end of 2023 have depreciated by £4,641.90. This gives a new value of fixed assets of £1,956.57.

There has been no change in basis for 2023.


Related party transactions
