The result was a decline in reserves of some £22,000.

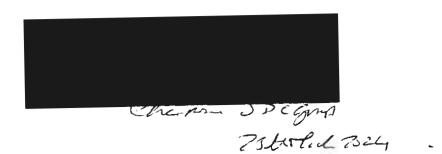
