Political activities

Overview of political activities

We continued to fight the Borough Election Campaign, which we started in September 2022. We fielded candidates in each of the 44 seats, and were pleased to retain control of the Council, with 25 seats. 3 of these represent a part of Rushcliffe that is now in the Newark Constituency. We fought these elections on the basis of new boundaries and 5 of our councillors retired. Overall, we lost 5 seats - 3 to Labour and 2 to Independents, one of whom stood in Cotgrave where he had been leader of the Labour Party! We took one seat from the Lib Dems.

Financial Activities

We spent more than £29k on the Borough Elections. With the 2022 spend, the total was around £40k, but the RBC Conservative Councillors' Political Fund contributed £20k in 2022. We were pleased with the results. The Council is 50 years old this year and has always been controlled by the Conservatives. RBC

is still debt-free, has the lowest Council Tax in the county, and is in the lowest 10% nationally.

Subscriptions are down 15% on 2022, with a few still coming in locally at the old rate of £25. Our Deputy Chairman - Membership is busy contacting these members to ask them to pay the additional amounts.

Repairs and maintenance costs amounted to £3560, which covered boiler maintenance, PAT testing, Mains testing and a HIVE Start being fitted to the Combi Boiler to keep better control of our heating costs.

We are still waiting for the two areas of flat roof to be replaced, which we have been promised will be done this spring/summer. We have reserved an additional £5000 for this work, as we are advised that the fire escape may need some alterations as well

Expenditure overview

Continuing expenditure

We purchased the marked registers, and the information has been inputted on VoteSource. Our officers have been busy negotiating new contracts with utilities suppliers to reduce future costs, particularly for telephone and broadband and gas and electricity.

Additional investment

None.

Balance sheet overview

The balance sheet is virtually the same as that for 2022, being down by only 0.49%, which given our expenditure on the Borough Elections is a very satisfactory outcome. The available cash is also very similar, being down by £149. The occupants of Rushcliffe House are as stated in 2022.
