# **Political activities**

#### **Overview of political activities**

Hinckley & Bosworth Conservative Association has continued to increase our activities year on year. From traditional leafleting to more contemporary social advertising, we have continued to campaign on issues that matter most to residents of Hinckley & Bosworth. This has been funded in part by an active fundraising calendar. These accounts show that the Hinckley & Bosworth Conservative Association is in a healthy position to continue our work in advocating for all residents in Hinckley & Bosworth despite making a small loss this year due to increased campaigning for local elections.

### **Financial Activities**

#### Income overview

Overall income increased by 9.3% during the year. This was mainly due to an increase in fundraising overall although branch income was slightly lower than the previous year. Rental income was also up on the previous year.

#### Expenditure overview

Continuing expenditure

Overall expenditure rose significantly in the year by 71.2%. The main increase was due to a threefold increase in campaigning expenditure which was entirely expected to the local elections. There was also a one-off payment of £2000 to the Mid Leicestershire Association formed due to the boundary changes.

### **Balance sheet overview**

The only significant movement on the balance sheet this year was a reduction in our bank balances which was entirely due to our increased expenditure which meant we ran a deficit of £8,327.
