Income levels fell slightly from approx. £22k in 2022 to £20.5k in 2023. This was broadly down to a reduction in membership of around £2k, though partially offset with £800 for a trophy auction sale. It should be noted that £1569.85 from the IPSA recharge for Apr - Sep 2023 expenses was received in 2024, so not reflected here.

Expenditure increased quite considerably due to local elections held in 2023 at both HDC and OWBC. Besides a couple of byelections we had no other major campaigning expenses in 2022. As a result, this increased from approx. £3k in 2022 to £18k in 2023. Overall expenses increased from approx. £16k in 2022 to £30k in 2023.
