## Iain Clifford Attendance - Conditional Acceptance

---

1. The occupant of the General Executor office of [IAIN CLIFFORD STAMP] estate, Iain Clifford offered to attend the FCA's alleged contempt of court hearing at Southwark Crown Court on 28<sup>th</sup> May at 10am on the condition that any party listed in the Conditional Acceptance section (Crown parties) of the 29<sup>th</sup> April NOTICE confirms in writing by affidavit or sworn statement the points at 45 a through x.
2. The NOTICES were delivered by certified mail to the Crown parties and formed a contract as per the postal rule of Adams v Lindsell 1818:
  - a. Why Iain Clifford is not a divine (holy) Spirit incarnate with life as a man, a living creation and child of God, a spark of the Supreme Creator, and Iain Clifford was not born again inheriting the divine estate from the Kingdom of Heaven as joint heir with Christ on Earth, as above so below.
  - b. Why the Crown, Southwark Crown Court, the FCA or any representative of the Crown, Southwark Crown Court or the FCA, specifically Pietro Boffa, Alasdair Mackenzie and Matthew Stone and or Judge Anthony Baumgarten (the Crown parties) has subject matter or in personum jurisdiction over Iain Clifford a living man under God's law.
  - c. Why the Crown, Southwark Crown Court, the FCA or any representative of the Crown, Southwark Crown Court or the FCA, specifically Pietro Boffa, Alasdair Mackenzie and Matthew Stone and or Judge Anthony Baumgarten say Iain Clifford is [IAIN CLIFFORD STAMP].
  - d. Why the Crown, Southwark Crown Court, the FCA or any representative of the Crown, Southwark Crown Court or the FCA, specifically Pietro Boffa, Alasdair Mackenzie and Matthew Stone and or Judge Anthony Baumgarten believe that Iain Clifford is the surety for [IAIN CLIFFORD STAMP].
3. The 29<sup>th</sup> April NOTICE was an offer to the Crown parties to contract, the Crown parties remain silent, neither accepting or rejecting the points detailed in the NOTICE, under the doctrine of tacit procuration the Crown parties agree that, Iain Clifford is a divine (holy) Spirit incarnate with life as a man, a living creation and child of God, a spark of the Supreme Creator, and;
4. The Crown parties have failed to evidence subject matter and in personum jurisdiction over Iain Clifford, and;

5. The Crown parties have failed to evidence that Iain Clifford is [IAIN CLIFFORD STAMP] or Mr Stamp, or “you” or “you’re”, and;
6. The Crown parties have failed to evidence that Iain Clifford has consented to act as surety for [IAIN CLIFFORD STAMP].

### **Court of Record**

7. This NOTICE, the 29th April NOTICE and all prior NOTICES were entered into the public record via Scribd under the link <https://www.scribd.com/user/513206069/Iain-Clifford>
8. All NOTICES published at Scribd under the Iain Clifford link remain unrebutted, all have been witnessed by hundreds of readers remain unrebutted and are perfected contracts, truth in law and judgements in commerce, the NOTICES are public record and form the foundation of the [IAIN CLIFFORD STAMP] office of the General Executor’s Court of Record.

### **Appointment of Attorney in Fact**

---

9. The occupant of the office of the General Executor Iain Clifford hereby appoints xxxxxxxx as Attorney in Fact to make a special appearance as an attorney in fact for the [IAIN CLIFFORD STAMP] estate and for Iain Clifford.

### **No contempt of Order 34 2023 by Iain Clifford**

---

10. Order 34 2023 was served against [IAIN CLIFFORD STAMP], the FCA refer to “Mr Stamp”, “you”, “yours” in witness statements and correspondence.
11. The Crown parties listed in the Certificate of Service section of the April 29<sup>th</sup> NOTICE contractually agreed via tacit procuration that Iain Clifford is not [IAIN CLIFFORD STAMP], Mr Stamp, “you” or, “your”.
12. Iain Clifford is not in contempt of court Order 34 2023 nor is Iain Clifford in breach of the subsequent discovery order. Iain Clifford has no assets, bank accounts, shareholdings, directorships or investments.
13. Iain Clifford is the beneficiary of all Cestui Qui Vie Trusts created from Birth Certificate number BXCK 056429, 15299187/1 and connected National Insurance number NI 83 40 80 D.

---

### **[IAIN CLIFFORD STAMP] Decedent Estate Abatement ab initio**

---

14. The Birth Certificate number BXCK 056429, 15299187/1 (attached) is accused by the FCA to be in contempt of court order 34 2023.
15. Birth Certificate number BXCK 056429, 15299187/1 represents a decedent estate, held within a Cestui Que Vie trust, a foreign situs temporary testamentary trust.
16. The date of birth of 27th January 1966 is the creation date of the decedent estate.
17. The Birth Certificate number BXCK 056429, 15299187/1 has a warning at the bottom of the Certificate c. “WARNING: A CERTIFICATE IS NOT EVIDENCE OF IDENTITY”
18. The legal name [IAIN CLIFFORD STAMP] represents a body corporate entity and is defined as a decedent by:

a. Ballentine's Law Dictionary Third Edition.

19. The United States Internal Revenue Service (IRS) confirms the Birth Certificate number BXCK 056429, 15299187/1 with connected National Insurance number NI 83 40 80 D is a decedent estate.

20. No criminal charges can be brought against a decedent, the law dictates the Abatement of Order 34 2023 ab initio.

**Office of General Executor Decrees the collapse of Order 34 2023, a Constructive Trust**

---

21. Iain Clifford claimed the minor estate of the [IAIN CLIFFORD STAMP] estate via NOTICES of living status and declarations compliant to the Cestui Que Vie 1666 and 1707 Acts.

22. [IAIN CLIFFORD STAMP] estate is held in Private Trust and is exclusively administered by the occupant of the office of the General Executor Iain Clifford.

23. Order 34 2023 is a constructive trust. The FCA and Judge Anthony Baumgarten presume to act as Special Executors of this constructive trust and appointed [IAIN CLIFFORD STAMP] as the trustee.

24. The occupant of the office of the General Executor Iain Clifford as the lawful beneficiary to the [IAIN CLIFFORD STAMP] estate via lawful standing:

a. Appoints Judge Anthony Baumgarten as Trustee of Order 34 2023.

b. Appoints Alasdair MacKenzie as Trustee of Order 34 2023.

c. Decrees the collapse of Order 34 2023 as Order 34 2023 does not serve the best interests of the beneficiary Iain Clifford.

25. Order 34 2023 is collapsed by the Decree of the occupant of the office of General Executor Iain Clifford and beneficiary of the [IAIN CLIFFORD STAMP] estate.

### No Consent - Challenge of Jurisdiction – Trial by Jury

---

26. If Judge Baumgarten or any Crown Judge ignore this NOTICE and previous NOTICE's and make a decision that harms the [IAIN CLIFFORD STAMP] estate or the occupant of the office of General Executor Iain Clifford does not provide consent to any decision and requires the court's jurisdiction challenged by a trial by jury, the jury to decide if:

- a. The Crown has subject matter or in personum jurisdiction over Iain Clifford.
- b. Iain Clifford is [IAIN CLIFFORD STAMP], Mr Stamp, "you" or "you're".
- c. Iain Clifford has ever provided consent to the Crown to administer the [IAIN CLIFFORD STAMP] estate.
- d. The Crown can charge a decedent estate.
- e. Iain Clifford has lawful standing as the beneficiary of all Cestui Qui Vie trusts connected to Birth Certificate number BXCK 056429, 15299187/1 with connected National Insurance number NI 83 40 80 D.
- f. Judge Anthony Baumgarten and the Alasdair McKenzie were appointed trustees of order 34 2023 by Iain Clifford as beneficiary and should collapse the trust.
